**Subject: Reg. Organizing International Day of Yoga-2023**

NMCG organizes International Day of Yoga annually in various cities & towns across 5 Ganga Main Stem Basin States,

2. This year's International Day of Yoga (IDY) endeavours to connect with a larger global community, as India's G20 presidency theme "One World, One Health" resonates with the principle of "Vasudhaiva Kutumbakam". Along with global outreach, IDY will focus on taking Yoga to each and every village in India through active participation of Gram Panchayat/Gram Sabhas.
3. In this backdrop, NMCG has planned to organize yoga sessions in Ganga Grams, villages, Ghats & water bodies on and near River Banks across the Ganga Main Stem States aimed to strengthen the people-river connect. (Refer: Action Plan at Annexure-I)
4. Fund of Rs. 50,000/- per DGC is allocated. NGP-Non EAP Funds to be released along with quarterly fund demand. (Refer: Funds Allocation at Annexure-II)
5. District Ganga Committee will be the nodal agency for implementing the activities of the International Day of Yoga on behalf of NMCG in close coordination with the State Mission for Clean Ganga. DPOs will lead the community mobilisation along with other volunteer groups and stakeholders- Ganga Vichar Manch, Ganga Task Force, Ganga Mitras and Ganga Praharis for organizing this activity in their respective areas. 6. The approval is subject to following terms and conditions:
  - SMCGs shall ensure that funds are transferred and utilized by the District Ganga Committee for this activity.
  - Ensure submission of the photographs with captions latest by 22<sup>nd</sup> June 2023.
