विषय:- गंगा एवं उसकी सहायक नदियों में शोधित उत्प्रवाह सुनिश्चित किये जाने के सम्बन्ध में महोदय,

मुख्य सचिव द्वारा आगामी महाकुम्भ-2025 के दृष्टिगत गंगा एवं उसकी सहायक नदियों में जाने वाले अशोधित उत्प्रवाह को पूर्णतयः शोधित करने की प्रतिबद्धता का निर्देश विगत बैठक में बार-बार दिया गया है। इस संकल्प को पूर्ण करने में जिला गंगा समितियों के सक्रिय योगदान की अपेक्षा है। उपरोक्त उद्देश्यों की पूर्ति हेतु प्रत्येक माह के द्वितीय शुक्रवार को होने वाली जिला गंगा समितियों की बैठक में निम्न बिन्दुओं का अनिवार्य समावेशन अपेक्षित है:-

- I. संलग्न सूची में अपने से सम्बंधित जनपदों के नान-कम्प्लायन्ट एवं नान-आपरेशनल एस०टी०पी० / सी०ई०टी०पी० को कम्प्लायन्ट एवं आपरेशनल बनाने हेतु कृत कार्यवाही का उल्लेख करें।
- II. जिन जनपदों में एस०टी०पी० / इन्टरसेप्शन एण्ड डायवर्जन की डी०पी०आर० स्वीकृति हेतु राष्ट्रीय स्वच्छ गंगा मिशन, नई दिल्ली में लम्बित है उसका भी उल्लेख करें।
- III. जनपद के अनटैप्ड नालों के सम्बन्ध में कृत कार्यवाही की आख्या अवश्य दें।
- IV. Ganga District Performance Monitoring System की प्रति संलग्न कर पुनः प्रेषित है। यह उल्लेखनीय है कि Sewerage Treatment Infrastructure Development तथा Industrial Effluent में Monitoring का Weightage 24 है। अतः उपरोक्त विवरणों की उपेक्षा प्रदेश की जिला गंगा समितियों की रैंकिंग नीचे कर सकती है।
- V. जनपद में औद्योगिक उत्प्रवाह पर विशेष ध्यान अपेक्षित है। यदि औद्योगिक ईकाईयों की PETP यथोचित रूप से कियाशील नहीं है अथवा औद्योगिक नालों एवं नदियों के कान्फ्लूएन्स प्वाइन्ट पर औद्योगिक प्रवाह मानकों के अनुरूप नहीं है तो आवश्यक रूप से प्रदूषण नियंत्रण विभाग के माध्यम से प्रवर्तन एवं दण्डात्मक कार्यवाही अमल में लायी जाय। आशा है कि आपका नियमित अनुश्रवण से नदियों में जाने वाले उत्प्रवाह को मानकों के अनुरूप सुनिश्चित किया जा सकेगा।

SCOPE OF WORK

1. Themes and Indicators

The Index comprises 10 themes (each having an attached weight), covering - Public Awareness, Preventing Solid Waste flowing into River, River -Front Development, Afforestation, Sewerage Treatment Infrastructure Development, Industrial Effluent Monitoring, Ganga Gram, Biodiversity, Institutional. The themes and their respective weights are displayed below (Indicator themes and weights). In Dashboard, in future there is a provision for addition/updation of new Theme and weights. The themes are further subdivided into 57 indicators, which are also listed below (NMCG district ranking).

It should be highlighted that the data collection exercises necessary to develop and populate the Index is unprecedented. Not only is data on several indicators being collected for the first time, but the exercise also involves deep collaboration amongst districts, as well as extensive NMCG - district coordination.
